- Pricing/Discounts:** Dealers for Daniel Crower LLC dba Daniel Crower Racing (DCR) and their employees agree to adhere to our set pricing when selling our products and those we resell. Dealers and their employees will not discount Daniel Crower LLC products and those that we resale or advertise for sale those products at any price less than the discounted price Daniel Crower LLC has set. It is the responsibility of the dealer and their employees to stay up to date on our current pricing through our website or through calling to request a current price list. - Advertisements/Promotions Approval:** Dealers for Daniel Crower Racing may use our company name, logo, products and product descriptions, unchanged, in their marketing, advertisements and promotional items as long as the marketing, advertisement or promotional item is approved by Daniel Crower LLC. - Competitors:** We do not want our Daniel Crower LLC products sold on dealer websites where our competitor's parts/components are also sold. If you are our dealer and you also sell for one of our competitors, you may not list our products on your website or do any advertising or promoting of our products in combination of any kind with our competitor(s). Please see #2 regarding approvals.
- Returns and Refunds:** Dealers, their employees and customers must adhere to our return policy and warranty statement at all times. If a dealer's customer returns an order to the dealer, the dealer must then return that order to Daniel Crower LLC under the terms of our return policy in order for a refund to be considered. Please ask your customers to return all orders to you, the dealer as opposed to DCR directly so the order is processed properly. All approved returns that meet the terms of our return policy are subject to; up to a 50% restocking fee or a non-acceptance of their return. Any camshaft that shows signs of installation, usage or wear of any kind will not be accepted. Due to the harsh high speed nature of racing engines and variables during installation we will not accept returns on any camshafts that are not in NEW condition. All returns must be un-used and without wear. For full details of our return policy and warranty statements please visit our website, download and print a copy for your records. There are NO returns on custom ground camshafts of any kind for any reason. Our camshafts and components are high performance racing parts not intended for everyday use. They are intended for serious racers and made for optimal power and performance, in a racing application and are not made for longevity past a normal race. While we do our best to walk a fine line between power, performance and longevity because our components are made for peak performance and power as first priority this may compromise longevity. As a dealer you must keep this in mind and relay this to your customers.
- Cancellation of Dealer Status:** This agreement can be canceled by either party upon written notice. Cancellation of dealer agreement contract does not mean that any unpaid orders don't have to be paid. All orders in process must be paid. If the dealer agreement is cancelled by Daniel Crower LLC the dealer discount will be revoked and any dealer discount applied to any processing order can be revoked at our discretion and payment in full of the retail amount will be expected.
